Re: Registration

Dear Family,

Welcome to the Seminole Sharks Swim & Dive Teams.

**To register a swimmer, diver, or both for the Seminole Swim & Dive Teams, there are three (3) forms to fill out and return:**

1. Registration form (electronic or [link](#))
2. All-City waiver form
  - a. Parent form (required for athletes <18 yrs old) ([link](#)), **OR**
  - b. Swimmer form (required for athletes >18 yrs old only) ([link](#))
3. Swim Team Buddies Form (optional) ([link](#)) - due by Friday June 5.

**3 checks are required to register a swimmer - 2 checks for a diver:**

1. Family booster fee of \$25 (for social events, etc.), make check payable to: Seminole Swim & Dive Booster Club
2. Team fees, make check payable to: Seminole Pool & Tennis Association
3. \$75 (held check) per swim team family (not applicable if diving only), make check payable to: Seminole Swim & Dive Booster Club (upon completing three (3) volunteer shifts, the check is returned/destroyed)

**Notes:**

- If you are registering your swimmer or diver for the FREE TRIAL (up until June 6<sup>th</sup>, including the intrasquad meet), please indicate this on the registration form and still complete registration & All-City waiver forms. If you choose not to continue after the 6<sup>th</sup>, your checks will be returned/destroyed.
- Swimmers and divers purchasing a team suit before Sunday May 17<sup>th</sup> will receive a free team t-shirt. Team shirts are available for \$7 after that period.
- Each swim team family needs to sign up for three (3) volunteer shifts to help run our three (3) home swim meets or other social events throughout the 2009 season.
